Central Savannah River Area Economic Opportunity Authority, Inc. is committed to facilitating the movement toward self-sufficiency, self reliance, and self determination by:





Monique is the founder of "Pretty in Pink". After being diagnosed with Breast Cancer in 2012, she wanted to recognize Breast Cancer Survivors in the community. In the month of October, she honors 5-10 ladies with a boat ride on the Savannah River, a personalized plaque, gift bag, photo shoot and a Pandora bracelet.

Monique Braswell is a native of Brooklyn, New York. She is a member of Wards Chapel Methodist Church, and the mother of four teenagers (Kareem, Rayshaun, Tahjai and Tahj). She is a woman devoted to her family and community. Monique is a strong advocate for children with ADHD due to all 4 of her children being diagnosed with the disorder. She speaks to different groups/organizations in the community, giving them insight and encouragement for their children who have this disorder.



Monique's relationship with EOA began when she moved to Augusta in January 2006. Homeless with no local support network, she enrolled in the EOA Supportive Housing Program where she was able to regain stability and establish permanent housing. Since that time she has become a major change agent in our community. For the past 9 years, Monique has served on the Board of the CSRA Economic Opportunity Authority Inc. Since 2007, she has collected donations to supply Christmas gifts for low-income families. From 2009-2012, Monique was President of Richmond County Council of PTA; under her leadership, the membership grew from 3,106-13,287. During her time as president and a member of the PTA, Monique organized a yearly book bag and school supply drive. Each year, this event supplied school supplies for over 3,000 children.

From 2009-2013, Monique sponsored an Annual Community Thanksgiving Dinner in which she fed 5,000-7,000 individuals at Lake Olmstead Housing, Cherry Tree Crossing and Oak Pointe formerly Delta Manor. During these years, she also sponsored the First Responder's Appreciation Day, where she prepared and fed breakfast, lunch and dinner to RSCO, RCFD and EMT and Disabled Veterans - over 1,100 meals.

For the past 4 years, Monique has been a mentor to 5 young girls ranging from ages 10-19. Last year, Monique started a scholarship fund called Live Like #25 in honor of Ricardell Sheppard (CJ), a T.W. Josey athletic student who passed away suddenly. Through this fund, two \$1,500 scholarships are awarded to graduating senior athletes who will be attending college.

Monique has partnered many businesses, organizations, and individuals to help her get things done to include Augusta Partnership for Children, Cher's Sisters only Club, PTA,
Amerigroup, Virginia College, Fifth Third Bank, 1st Bank, Richmond County Board of Education, Wheeless Road Elementary School, Murphey Middle School, Josey High School, Richmond County Transportation, Power 107 and 96.3, Commissioners William Fennoy, Joe Bowles, Alvin Mason, Corey Johnson, Wayne Guilfoyle, Joe Jackson, CSRA EOA, Inc., US Army and Navy. Monique Braswell is a person who does things to bring the people together to help others, and who lives "for the people, by the people, and of the people."







Continuum of Care for the Homeless, is proud to announce that it has been awarded funding from the U.S. Department of Housing and Urban Development (HUD) to institute a Centralized Intake facility for residents of Augusta-Richmond County who experience housing instability and find themselves in need of service. Slated to launch by October 1, 2016, the Centralized Intake facility to be operated by EOA will provide a single, centralized point of access for community members, Partner Agencies and interested volunteers to coordinate the efforts to address homelessness and housing instability in the local community. The main goal of the Centralized Intake Project is to improve the efficiency and effectiveness of the community's crisis intervention strategy and response capacity for persons experiencing homelessness as well as persons at-risk of experiencing homelessness. The project is expected to serve 1,900 to 3,000 people over the course of one year, and will create two new job opportunities.

Supportive Services for Veteran Families (SSVF)

Accomplishments

163 families consisting of 301 people were served

We were able to re-house 53 homeless veteran families.

We were able to prevent homelessness for 50 veteran families.





For the last four years CSRA Economic Opportunity Authority, Inc. has served as lead agency in a partnership with Augusta Warrior Project and Goodwill of Middle Georgia and the CSRA. Each has brought their own expertise to the table.

Augusta Warrior Project's developing a proactive relationship with Veterans in order to prevent or mitigate life crisis by holistically addressing issues early and collectively with their partners. Veteran assistance is coordinated by Augusta Warrior Project advocates. Their collaborative relationship with local, state, and national organizations ensures the well-deserved support for our Veterans and their families.

Goodwill Industries is North America's leading provider of workforce development services. Goodwill's vast experience in both the attainment and successful implementation of federal grants and their organizations successful experience in assisting veterans with job training and placement services have provided increased opportunity for employment and retention of veterans in high demand occupations.

Overall the partnership has worked very hard to serve those who served us.

Serving Those Who Served Us

G. L. is a 62 year old veteran who served in the U. S. Marines from 1982-1986. He stated that his troubles started in February of 2012 when he became ill on his job and eventually lost his employment. He took on day labor jobs to try and provide for his family; however the loss of income caused stress on the marriage, and he was asked to leave the home. A short term stay at the VA Domiciliary brought about an opportunity for him to connect with the CWT program to learn a new skill. The excitement of this new venture was short-lived however because a series of crises was ahead. G. L. had continued to work the day labor jobs and began saving for his own place, but his car broke down while on a job assignment, and the threat of having the car towed also meant a loss of housing, as his sole personal possession had also become his home. Unable to recover the vehicle, he moved from the couch of one friend to another before making contact with the SSVF program. He was referred to Goodwill Job Connection and a Veteran's Rep at the GA DOL for employment search; however, a prostate cancer diagnosis caused him to be unable to work. G. L.'s case manger then linked him with mainstream resources and helped him to obtain food stamps and Supplemental Security Income. He and his case manager also initiated the application process for a VA disability claim, and qualified him for financial assistance through EOA's Community Services Block Grant (CSBG) to obtain stable housing of his own. Well on his way, G. L. is glad for the partnerships and services that afford him this fresh start.

HOMEOWNERSHIP PLANNING & EDUCATION (HOPE)



When the Carnell family entered the Telfair To Home Program, they were struggling to pay their monthly expenses, had extensive debt, and their bank account was overdrawn. Mrs. Carnell cried as she discussed the family's financial situation and expressed that she saw no way out. Although they knew that moving a family of five into a two bedroom apartment would be tight, they were committed to make the transition, since the lower rent offered by the Telfair To Home Program would free up \$335 in their monthly budget.

Not only did they sacrifice space, they also sold some of their belongings on Craigslist, and found alternate homes for their pets, as means for bringing their finances into order. After several months of housing counseling, the Carnells were following a budget, saving, and paying off debt. Mr. Carnell received a raise, and Mrs. Carnell obtained part-time employment. Both of their credit scores increased, and the couple was able to discuss their finances with a sense of relief and in laughter, rather than through tears.

After sixteen months of dedicated efforts to improve their finances, the Carnell's put an offer on a home and became the proud owners of a 5 bedroom, two bath home in Thomson, where they moved to be part of a church plant.

In an e-mail to his Housing Counselor, Mr. Carnell had this to say:

"We thank you and the program for the financial expertise and opportunities afforded to us. We would also like to keep our relationship going with you. I believe the last time we talked you said that even if we leave the program you would still counsel us in the handling of our finances."

The Carnells are the first family to participate in the Telfair To Home Program, which is designed to be a "homeownership incubator" of sorts - providing an affordable rental unit coupled with pre-purchase counseling, so that the families can prepare for home purchase. The program is a partnership between CSRA EOA, Inc., and City Hope Alliance. City Hope Alliance owns and manages the rental unit, and CSRA EOA, Inc. helps select families for participation and provides pre-purchase counseling to those families. With the Carnell family's success, City Hope Alliance is considering expanding the program by purchasing a second property that could be used for the same purpose.

INDIVIDUAL Pre-Purchase Counseling

171 families received pre-purchase counseling, of which 11 purchased homes.

Foreclosure Intervention Counseling

70 families received foreclosure intervention counseling. Of that number, 19 resolved mortgage default, and the majority remain in progress of a resolution.

GROUP HOMEBUYER EDUCATION & FINANCIAL LITERACY

38 families completed a Homebuyer Education Workshop, and 15 completed a Financial Literacy Workshop.

Program Description

The Emergency Solutions Grant (ESG) Program provides outreach, shelter, rapid re-housing, homelessness prevention and related services to persons experiencing homelessness, or for persons in danger of becoming homeless, throughout the state. Assistance is provided to members of the community, local government entities and non-profit organizations utilizing State Housing Trust Fund for the Homeless Commission (HTF) and Federal HUD ESG funds. This program is principally designed to be the first step in a continuum of assistance to enable homeless individuals and families to move toward independent living as well as to prevent homelessness.



Neighborhood Service Center Case Management & Crisis Intervention

For a year and a half volunteer, Allene Black has hauled groceries from the local **BI-LO** over to our **Burke County Neighborhood Service Center**. At no charge to us, every Wednesday she gases up her husband's pick-up truck and delivers meat, dairy, produce, frozen, deli/ bakery, grocery and non-food items donated by the grocery chain. Dear EDA,

I am honored to be writing this paper expressing how the EOA has helped my family and I. When we first contacted EOA, my husband and I were both in separate Drug Rehabilitation facilities. I was at Hope House with our two children and he was at The Salvation Army. These programs taught us how to live in the world sober, but didn't have the resources for transitional housing. So we heard through someone that the EOA might help us. The EOA and our case manager did more than just help us. They also gave us a second chance at life. Coming out of a rehab facility, we didn't have much at all. We didn't have any money saved up, we didn't have good jobs, we didn't have an established positive rental history, and our credit score, well we aren't even going to go there. We were honestly on the verge of becoming homeless even after all of the hard work we completed in our rehabs and our vow to change our lives. Upon meeting Mrs. Bethany Trapp, we were treated with the utmost respect and dignity that many others may not have thought that we deserved. She didn't look at us like two addicts that had screwed up their lives, she saw us as a family who wanted a fresh start and a second chance at being together, and that is exactly what was given to us through this wonderful program. We moved in an apartment that the EOA agreed to help us pay for on October 27, 2014. This day will always be marked in my heart as one of the greatest days of my life and that I will never forget. We couldn't believe that God had blessed us with the discovery of this program. Since October of 2014 the program has assisted us with life skills classes, community resources, credit counseling services, Christmas presents, and even down to the comforters on our beds. My husband was able to get promoted at work, I was able to save up money to buy a vehicle, but in my opinion, the greatest, thing that the program has been able to offer me is the ability to achieve my dream- graduating from college. In February of 2015, I was able to enroll in a medical program at a local college. This wasn't just about getting a degree, this was about chasing my dream, being able to make a life for myself and my family; doing something I was passionate about. This June I will be graduating with a 4.0 GPA and I will have a certificate in Medical Assisting as well as being phlebotomy certified, CPR and BLS certified, and Sim Charting certified. I would have never imagined that I would be at this place in my life now. We have been given the tools and the opportunity to save money so that now we can move out and make it out there on our own two feet, and most importantly the opportunity to advance at new careers. None of this would have been possible without the help of the EOA program and especially Mrs. Bethany Trapp. She has been patient, kind and helpful in assisting with the shaping of our futures. I will never be able to thank you all enough for everything you have done for my family and I. But please know we will always continue to carry the gratuity in our hearts for you all coming into our lives, giving us a real chance at a future, and hopefully one day, we can be given the opportunity to help others.

14 homeless families were housed through SHP in FY2015,

10 participants gained/ maintained employment; 3 enrolled in secondary education programs, and 2 exited the program for permanent housing opportunities.

Senior Nutrition Program

The Senior Nutrition Program provides homebound and congregate meals, nutrition education, exercise, wellness and recreation activities, and linkage to other vital services and resources for seniors. Nutrition assistance supported by CSBG dollars is provided in collaboration with senior centers in Burke County, McDuffie County, Jenkins County and Emanuel County. Burke County Senior Center is operated by EOA staff, and supported by federal, state and local government funding. During FFY 2015, Burke County Senior Center provided meals to 210 senior participants; 112 of these participants received congregate meals.



For many years **Burke County Senior Center** has partnered with **Burke County Transit** to provide transportation for congregate meal participants to access meals, field trips, health fairs and other resources. During FFY 2015, Burke County Transit provided transportation to more than **60 participants daily**. As food insecurity and transportation are major barriers to wellness for seniors, this partnership plays a vital role in **helping our seniors** maintain health and independence.






CSRA EOA, Inc. is a private non-profit corporation which operates a Head Start Program that provides professional comprehensive quality services to preschool children, families, staff, and the communities of Bulloch, Burke, Columbia, Emanuel, Jefferson, Jenkins, Lincoln, McDuffie, Richmond, Screven and Warren Counties.

Vision Statement and Projected Goals

CSRA EOA, Inc. Head Start will be an Agency whose efforts and quality will continue to improve while achieving excellence, and serving every eligible child and family who desire services over the next five years.

Goal 1: Promote School readiness of low-income children by enhancing their cognitive skills, social skills, and emotional development.

Goal 2: Establish learning environments for the development of children's speech and language, literacy, math skills, science comprehension, social and emotional skills and physical development.



Goal 4: Coordinate Family and Community Engagement activities and resource utilization to assist parents in their pursuit of social competence and self-sufficiency.

Monitoring/ Quality Assurance

Anderson and Adkins completed the Agency's annual audit. Copies of the results are maintained in the Agency's records and filing system.

All the centers are monitored for quality assurance. Although the State of Georgia does not require a license to operate, Head Start has voluntarily completed all necessary requirements to secure license for the following sites: Augusta Technical College, Clara E. Jenkins, Deans Bridge, Lincoln, McDuffie, Pathways, and South Richmond.

McDuffie and South Richmond Centers earned the "Center of Distinction" designation from the State of Georgia. Clara E. Jenkins has received NAEYC accreditation.



In 2012 the State of Georgia implemented a Quality Rating System (QRS), a mechanism that is used to improve and communicate quality care in an early childhood education setting. This agency elected to participate in this process. Quality Rated assigns a rating (one star, two star, or three star) to early education and school-age care programs that go above and beyond minimum licensing standards. By participating in Quality Rated, child care programs demonstrate their commitment to continuous quality improvement. Participation in QRIS is a marker to parents and the community at large that the services provided by this agency are of high quality and will be monitored as such. All of our centers have submitted the application for QRIS. Listed below are the ratings:

Three-Star: Emanuel, Jenkins, and Louisville Centers

Two-Star: ATC, Bert T. Thomas, Bulloch, Burke, Clara E. Jenkins, Columbia, Lincoln, McDuffie, Pathways,

Screven, South Richmond, Wadley, and Wrens Centers

One-Star: Deans Bridge, Floyd and Warren Centers

The Agency provided all training in the required areas and other essential topics. Annual pre-service training was conducted prior to the opening of school. In-service training sessions were provided for all staff. Additionally, area training that is job specific was held during the school year. Staff and parents attended conferences that enhanced and developed their knowledge base.

The agency developed and implemented a monitoring system that provided data that was useful to enable the administrative team to review data technologically, visit sites for observations, interviews, and record checks. Information obtained in this process was utilized to strengthen program operations and to make determinations about the effectiveness of existing policies and procedures.

CSRA EOA, Inc. is committed to hiring and maintaining quality classroom teaching staff. The program actively works with all staff to assist in the attainment of higher educational opportunities. Ten hours per week are available for educational sessions. Assistance with tuition, travel, child care expenses and other fees are provided for teachers as they work to meet the degree mandate which requires teachers to have a Bachelor's degree in Early Childhood Education or a related field. According to the most current Program Information Report (PIR), CSRA EOA, Inc. has exceeded the teacher credential requirements of section 648A of the 2007 Head Start Act.

Agency Overview

Central Savannah River Area Economic Opportunity Authority, Inc. was established in 1966, and received designation as a Community Action Agency under the provision of the Economic Opportunity Act of 1964. It is a private, non-profit agency.

The Agency has a tripartite 27 member board of directors consisting of at least one third democratically elected representatives of low-income people, one third local public officials or their designees, and the remainder, representatives of business, industry, labor, religious, social welfare and other private groups in the community. The formation of the Board of Directors meets requirements of the Head Start Performance

As the Agency celebrates more than 50 years, its mission has not changed, but rather has expanded in efforts to reach as many disadvantaged children and families as funds will permit. Presently, the service areas include a total of 14 counties of which 11 have Head Start Centers.

The Policy Council

The Policy Council of CSRA EOA, Inc. was organized in accordance with the Head start Performance Standards. It is comprised of 51% parents of children enrolled in the program and 49% community representatives. Members of the Parent Committee at each center elect a representative to serve on the Policy Council. Individuals from each county were recommended and approved by the Council and Board of Directors to serve on the Council as community representative. Members comprising the Policy Council were installed in October. The members are committed and have taken their positions and responsibilities seriously. The attendance rate is commendable; each representative fully participates in the business of the Council. This can be shown in their decision making and reporting actions.

Training for the Council was provided as part of the monthly meetings and joint training for the Board and Council was provided in September to familiarize members with their roles and responsibilities and other essential information.

Program Enrollment


CSRA EOA, Inc. Head Start Program provided comprehensive pre-school services to 1,459 three and four-year old children and families of which 260 children and families receive Pre-K blended services. All children receive the full array of Head Start services that are provided in the areas of education, medical, dental, nutrition, mental health, disabilities, parent involvement, social services, fatherhood activities, community partnerships, transportation, and transition. Three hundred and fifty-two people are employed to work in the Head Start Program from the communities served.

The program operates a full day, center based program option in which the children attend the program up to 6.5 hours per day for an average of 175 days. The local public school board calendar for each county is followed to develop the Head Start calendar for that county. The following information lists the counties in the CSRA EOA, Inc. service area that provide Head Start and Pre-K services:

Program Services


Early Childhood Education Services

The Program uses the Creative Curriculum as the primary source for selecting individual and group activities; however, many other useful sources are utilized: Second Step, Safety Sam, and STEPS Emergent Literacy enhance the classroom activities. Children are screened using the Learning Accomplishment Profile Diagnostic (LAP-D) Instrument and are assessed using Teaching Strategies Online, which compliments the curriculum.


Head Start has always prepared children for entry into public school. The expectations of school preparation changed to require programs to develop a school readiness plan that aligned program goals with state and local school systems' goals and expectations. The program's school readiness goals are aligned with the Head Start Early Learning Framework (HSELOF), Georgia Kindergarten Inventory Developing Skills (GELDS), and Georgia Early Learning and Development Standards (GELDS). The goals are:

- SRG #1 Children will self-regulate emotions and participate constructively in group situations.

The Classroom Assessment Scoring System (CLASS) is implemented to obtain information relative to teacher/child interaction. The information enables management staff to determine skill levels of the teaching staff and provide staff development opportunities that will improve their skills. Special curriculum is used during the transport of children that mirrors classroom activities. Meals and nutritional activities with children contribute to the holistic approaches used for child development by the program.

Transitioning

The program continues to be engaged in the transition process both into and out of Head Start. This process includes: Parents, Community Organizations, Childcare, Babies Can't Wait, School System and Early Head Start Programs (Burke and Emanuel counties). Prior to the beginning of the school year, transition into Head Start begins. Registration, Parent Orientation to the Head Start Program, and Center Visits are transition activities provided for parents. The orientation for children and parents occurred at the beginning of the school year when they both came to school for a half day to meet teachers and to tour the property.

As vacancies occur during the school year, parents and children experience transition into Head Start. This includes orientation to Head Start Program, registration, and center tour. The transition out of Head Start begins in January. The students are utilizing trays to familiarize themselves with cafeteria style process in the public school.

Professional Development

Head Start strives for excellence at all times. An added assurance to achieving excellence in the program, are provisions for the staff to enhance their skills through both formal and informal training and technical assistance. Ten hours per week are available for staff pursuing educational goals in their job specific field at Institutions of higher learning. Teachers are especially targeted to ensure that they meet the Health and Human Services (HHS) and Agency Degree mandate which requires all to have a Bachelor's Degree in Early Childhood Education or related field by December 31, 2015. Assistance with tuition, travel, and child care expenses was provided to teachers.

The teacher assistants have the Child Development Associate Credential (CDA) and the Early Childhood Education (ECE) diploma or the TCE, and are working toward their Associate's Degree or Bachelor's Degree. Achieving their Bachelor's Degrees will place them at an advantage for promotional opportunities as vacancies occur.

All staff receive training as required by the Head Start Regulations, School Readiness, and State requirements.

Transportation

Transportation was provided for approximately 95% of the enrollees. Each bus driver is a CDL with P & S endorsements. A driver and a monitor are assigned to each bus. Both employees receive all required training. A bus curriculum was utilized for continuous learning. The buses are equipped with required safety items. The Transportation Specialist was instrumental in the development of bus routes. All persons who drive agency vehicles must obtain a Motor Vehicle Report (MVR). Agency vans are available for staff travel to perform work requirements.



Nutrition

Children participated in the Child and Adult Care Food Program (CACFP). Breakfast, lunch and snack were provided. All Cooks are ServSafe certified. Children who were identified with low hemoglobin or hematocrit were monitored. Nutritional information was provided to the parents on how to prepare meals that would enhance the hemoglobin and hematocrit to normalcy.



Family and Community Engagement

CSRA EOA, Inc. has engaged several partnerships within the communities to provide quality services to children and families. The Boards of Education for Bulloch, Burke, Jefferson, Lincoln, McDuffie, and Richmond Counties provide facilities. The cities of Harlem, Warrenton, the Augusta Housing Authority and the Jenkins County Commission also partner with the Agency to provide facilities along with the YMCA, and New Zion Hill Missionary Baptist Church. Wal-Mart, International Paper, the Alpha Chi Lambda Chapter, of the Alpha Phi Alpha Fraternity, Inc., Doubletree Hotel, Trinity CME Church, T. J.'s Garage, Caring for Others, local companies and charities donate items for the children throughout the school year.

Georgia Regents University, local health departments, the school systems in all counties served, county libraries, doctors, dentists, other medical specialists, the Department of Family and Children Services, Augusta Technical College Nursing Students, and Burke and Emanuel Counties Early Head Start plays a vital role in the success of the Head Start Program. The engagement of the community resources help to impact the service needs of the children and families. Additionally, the engagement of parents makes a major difference to help bridge the gap between the home and the center for developing children and families; moreover, helping the families to achieve self-sufficiency.

Parents play a pivotal role in the program by serving on Center Committees, Policy Council, and Advisory Committees. They also assist the Program with the self-assessment, program planning, curriculum planning, center activities, and participate in parent training and other functions that enhance the program outcomes. CSRA EOA, Inc. Head Start has a menu planning committee comprised of parents who provide input on menus, and other information relative to the nutrition area, which assists with meeting HHS and USDA regulations. Recipes are submitted by parents and staff to develop a recipe book. The book is published biannually. Some of the other activities include: **Parent Trainings, Field Trips, Health Fair, Fatherhood, Menu Planning, Classroom Volunteers, Health and Education Advisory Committees**

We have several notable functions that have proven to be beneficial to the program and parents. The most successful programs are our Annual Parent Conference and the Joint Board of Directors and Policy Council Training that are held in the fall of each year. The conference and training are geared toward empowering parents to develop job skills, parenting skills, and personal growth and development.

Eligibility, Recruitment, Selection, Enrollment, and Attendance

The recruitment of children is an ongoing process. Children are deemed eligible who meet the eligibility criteria set within the federal regulations. Children with the greatest need are selected for enrollment. Flyers, door to door canvassing, media releases, exhibits at community affairs, participation in area parades, and wearing Head Start T-shirts, are examples of methods utilized for recruitment. It is required that the program maintains a minimum average daily attendance of 85%. The 85% is always exceeded.

Advisory Committees

The Program has an active Health Services Advisory Committee (HSAC). It is composed of parents, medical and dental partners, Local Health Department representatives, Amerigroup, contractors, DFACS representatives and staff. This Committee assists with program planning, health services, and provides other information relative to meeting the health/nutrition, and disabilities needs of children and families. The HSAC provides information for use by parents in the home to ensure preventive health care measures. This committee provides professional suggestions for health care and current health trend strategies that are useful.



The HSAC was instrumental in having a mobile dental unit set up at several Head Start centers to provide dental exams to Head Start children. Health clinics were held at the suggestions of the HSAC, to provide physicals, sensory and other screenings for the children. The School Readiness Committee is composed of parents, community partners, and staff. This Committee assists in making decisions regarding approaches to child development that the program will implement. Information shared from the cross-section of members assists with securing services continuity.

The menu planning committee is composed of parents and staff who provide input on menu planning and development and, nutrition tips for healthy living. As members of this committee, parents have an opportunity to check the services for compliance with USDA and Head Start Requirements.

Parents on the committee collect recipes from parents in their center for inclusion in the recipe book that is developed, published and distributed biannually.

Technology

The Program utilizes "ChildPlus.net Software" as its recordkeeping system and "Teaching Strategies Online" to conduct child assessments. Administrative and center staff have access to computers to utilize in reviewing and accessing records as part of the recordkeeping process. Each classroom is equipped with computers that are used




